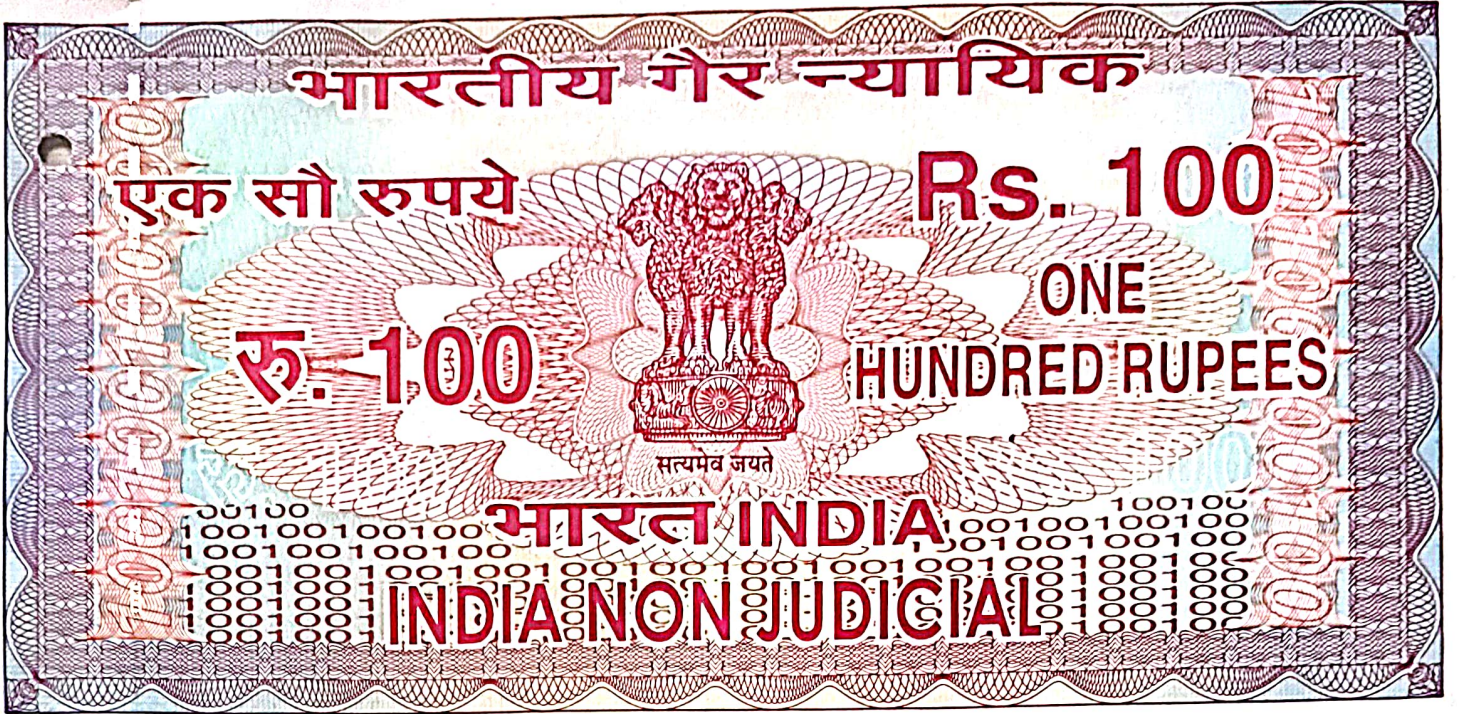
WHEREAS the Founder has desirous of forming a Public Welfare Charitable Trust for Welfare and EDUCATIONAL purposes.

II. The founder of the Trust do hereby constitute an irrevocable Trust with an initial corpus fund Rs.1,000/- (Rupees One Thousand Only) in cash for the purpose of carrying out the objects of the trust hereby created and all income there from and all accumulations, additions, accretions or otherwise an augmentations there to for the objects intents and purpose hereinafter mentioned.

The founder of the Trust do hereby expressly confirms and affirms that there will not be any amendment to this deed to alter the basic objects of the Trust and further affirms that no such amendments which may prove to be repugnant to the provisions of sections 2(15), 11 & 13, 80G and such other applicable provision of the Income Tax Act and may be in force at the time of making of such amendments.

V. THE OBJECTS OF THE TRUST ARE AS UNDER:

1. The name of the Trust shall be **V.K.S. EDUCATIONAL AND CHARITABLE TRUST** The office of the Trust shall be situated at Rental in No.1, V K S Complex, Manimannan Trader's, Sendurai Road, Natham, Dindigul - 624 401 or such other Place or Places, which the Trustees may decide from time to time.

2. Main Objects for which the trust is formed are:

- a. To Provide fees, books, equipments, free ships, and/or scholarships to deserving students.
- b. To feed poor students and to start free student homes and free hostels.
- c. To help and assist poor and deserving people in marriage.
- d. To conduct seminars/workshops and arrange special tuition / training for students.
- e. To provide / assist in setting up laboratories.
- f. To make donations to other public charitable Trusts / institutions recognized under section 80-G of the Income – Tax Act, 1961.
- g. To set up and operate schools / colleges.
- h. To conduct nutritional and health services.
- i. To conduct / operate programmers for providing nutritional assistance e.g. to operate a school / lunch / food programme for children, operate nutritional supplement programme for needy women which shall be provided / conducted / distributed free of charge.
- j. Testing of diets from nutritional view point.
- k. To render assistance to poor patients by providing medicines etc., provisions of health care, preventive medical services (including dental services).
- l. Assistance to hospitals in setting up the various facilities such as Blood Bank, Eye Bank, Burn centers, etc. for the poor patients.
- m. Provision of outdoor dispensary or assistance thereof and also to run "Mobile" medical services.
- n. Conduct educational in health care or provide assistance I the provision of primary health care education.
- o. To set up hospitals / nursing homes for children / women.
- p. To render assistance to the handicapped.
- q. To provide monetary assistance and social services in case of natural calamities.

- r. To render financial assistance to the handicapped.
- s. To Promote and advance moral education, charity and general welfare of the people.
- t. To offer a medical welfare to the Public and arrange a program like arranging flood donation camp, eye care and awareness camp. Also provide free check up. Motivating eye donation and organ donation
- u. For the drug addicts, arrange the awareness program and providing drug relief treatments.

3.To donate either in cash or in kind, support, help, aid, subsidies and render financial assistance to all Individuals, Trusts and institutions which have objects similar to the objects of the trust and which deserve support of reason of the loyalty of operation or otherwise.

The above objects shall be independent of each other and the Board of Trustees herein constituted may from time to time apply the funds of the trust in carrying out all or any of the aforesaid objects of the trust as it may in its absolute discretion think fit.

VI. TRUST FUND

- a. The Author of the Trust declare that a sum of Rs.1,000/-(Rupees One Thousand Only) has been dedicated by him for Public Welfare Charitable purposes and objects of general public utility described above and the Trustees shall and will stand possessed the said sum of Rs. 1,000/-(Rupees One Thousand Only) upon Trust and also any other properties, whether movable or immovable, which the Trustees may from time to time receive for augmenting the Trust or Special purposes connected with the objects of the Trust not connected to impede the due working of the Trust arising from donations, requests or from other sources whatsoever and also of any investments for the time being representing the same (here in after called the Trust Fund) and also of the net income from the Trust Fund for the purposes of the Trust.
- b. The Trustees hereby acknowledge receipts of the said sum Rs. 1,000/-(Rupees One Thousand Only).dedicated by the Author of the Trust.
- C. It is hereby declared that as on date the Trust does not own any movable or immovable properties.

- b. Except or otherwise provided herein, none of the trustees for the time being of the trust shall have power jointly or severally to mortgage, charge and/or alienate any of the trust properties.
- c. The initial contribution of Rs.1,000/- made by the Founder of the Trust shall hereby vest in the trustees and shall constitute the initial corpus fund.
- d. The Managing Trustee shall have the power to acquire and/or take on lease any suitable landed properties from any individual or any Government Body like Corporation, Municipality, Panchayat or such other status and to construct buildings and structures with all requisite electrical installations in such acquired land with the intention of fulfilling the objects of the trust.
- e. The Managing Trustee shall have the power to administer, appoint, employ, remunerate and to remove employees and / or officers.

IX. Without prejudice to the powers of the board of trustees, the Managing Trustee shall have power

- a. To employ clerks, accountants and other employees, lawyers, attorneys, consultants, other required personnel and/or body at such remuneration and on such terms and conditions as may be approved by the Board.
- b. To delegate any powers to one or more of their body.
- c. To delegate any powers as he can lawfully delegate to any person and to execute such power of Attorney as he think fit for the purposes and to withdraw or revoke any appointment of any employees or attorney.
- d. To let out any portion of any immoveable property forming part of the trust and at such rent and/or such period and on such terms and conditions as may think fit and to accept surrender of any letter.
- e. To borrow money with or without security or pledge, mortgage or otherwise charge any of the properties belonging to the trust for the purpose of raising loan.
- f. To represent or act for the trust in any matter concerning the properties, funds, investments, borrowings, subsidies, grants, aids, licenses, permissions, clearances, disputes etc in person or through representatives authorized by him.

XVII. GENERAL

- a. This Trust shall be irrevocable.
- b. All acts and proceedings of the trust shall be taken and conducted in the name of the trust.
- c. The Trustees shall have power to add/amend and alter the trust deed by majority decision and such addition/amendment and alterations will be carried out only with the prior approval of the Commissioner of Income Tax or such other appropriate designated authority in this regard as may be appointed from time to time.
- d. Income and funds of the Trust shall be solely utilized towards the objects of the trust and no portion of it will be utilized for payment to trustees including the Founder of the trust or any person who has made a substantial contribution to the trust by way of profit, interests, dividends etc.,
- e. The trust is formed for servicing general public without any reservation and hence the benefits of the trust are open to all irrespective of caste, religion, sex etc.,
- f. No activities of the trust shall be carried out outside India.
- g. The trust shall not carry on any activity in the nature of a business activity and/or with the intention of earning profits.
- h. The trustees shall, at all times, be indemnified in respect of all bonafide acts that have been done by them relating to matters of the trust.
- i. The trustees shall have power to accept donations in money or otherwise for the purposes of the trust.
- j. Rules may be framed for the proper administration of the trust, but such rules shall not be against the objects of the trust as in Clause VII above.
- k. Any trustee for the time being of the trust may call a meeting of the Board on due notice and specify the subjects to be considered by the Board in the meeting be mentioned in the notice of the Board.
- l. In the event of the votes being equally divided, the Chairman of the meeting shall have a casting vote in addition to the vote as members of the Board.
- m. The Quorum for any meeting of the Board shall be One Third of total strength or two whichever is higher.

In the event of the Trust not being able to function in fulfillment of the objects of the trust for any reason whatsoever or in the event of closure or dissolution of the trust, after discharging all the liabilities, the trustees shall transfer the assets of the trust including the corpus to any public trust or institution having not only similar objects but also enjoying recognition and exemption under section 80G of the Income Tax or such other applicable provisions of the Income Tax Act as amended from time to time and as may be in force at the time of transfer, as decided by the majority of the trustees present at a meeting called for that specific purpose and acted upon..

For all other matters not mentioned in this Trust Deed the provision of the Indian Trust Act, 1882 shall apply.
